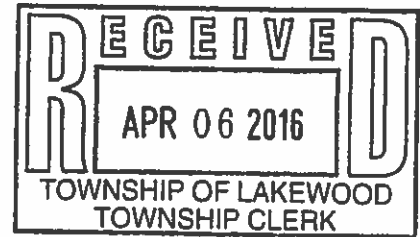


TOWNSHIP OF LAKEWOOD  
NOTICE TO BIDDERS



PLEASE TAKE NOTICE that sealed bids will be received by the Board of Fire Commissioners of Fire District No. 1, Township of Lakewood, for a licensed electrical contractor to supply labor, material and fixtures for lighting projects through the New Jersey Clean Energy Program on Tuesday, April 12, 2016, at 12:00 p.m. prevailing time at the Office of the Board of Fire Commissioners, 316 River Avenue, Lakewood, New Jersey, at which time they will be opened and read by the Board Clerk or designated representative.

Bids must be enclosed in a sealed envelope marked "Licensed Electrical Contractor Bid" on the outside addressed to the Board of Fire Commissioners of Fire District No. 1, Township of Lakewood. The bid must be delivered to the Board of Fire Commissioners, Fire District No. 1, Township of Lakewood, 316 River Avenue, Lakewood, New Jersey, at 12:00 p.m. on April 12, 2016. If mailed, all bids must be mailed by Certified Mail to the Board of Fire Commissioners of Fire District No. 1, Township of Lakewood, 316 River Avenue, Lakewood, New Jersey 08701, and received on or before the above set forth time and date.

No bid will be considered unless in writing on the form furnished.

Bids may not be faxed, transmitted over the telephone or emailed. The Board of Fire Commissioners of Fire District No. 1, Township of Lakewood, assumes no responsibility or delays in any form of carrier, mail or delivery service causing the bid to be received untimely.

Bidders must submit with the bid an "Ownership Disclosure Statement" and "Non Collusion Affidavit" on the forms included in the bid package.

Bidders must submit proof with the bid of registration with the New Jersey Department of Treasury, Division of Revenue, by submitting a copy of bidder's Business Registration Certification.

Pursuant to N.J.S.A. 10:5-31, bidders are required to comply with the requirements of P.L. 1975, c.127, N.J.A.C. 17:27.

The Board of Fire Commissioners of Fire District No. 1, Township of Lakewood, reserves the right to reject any or all bids not deemed to be in the best interest of the Fire District.

It is the purpose of the Notice to Bidders to summarize some of the provisions of the bid documents. Prospective bidders are cautioned not to rely solely on this Notice but to read the bid documents in their entirety.
