## AN ORDINANCE OF THE TOWNSHIP OF LAKEWOOD, COUNTY OF OCEAN, STATE OF NEW JERSEY, CHANGING THE NAME OF A STREET TO HUNTER DRIVE (FROM YECHIEL WAY) PURSUANT TO AND IN ACCORDANCE WITH N.J.S.A. 40:67-1(k) ET SEQ.

- **WHEREAS**, the purpose of the within ordinance is to change the name of Yechiel Way to Hunter Drive, pursuant to the request of township officials and the property owners fronting on Yechiel Way; and
- **WHEREAS**, pursuant to the provisions of N.J.S.A. 40:67-1(k), et seq., the governing body of a municipality may make ordinances to provide for the changing of names of streets within the municipality; and
- **WHEREAS**, the property owners fronting on Yechiel Way, a small dead end street off London Avenue as shown on Tax Map Sheet 124.02, have agreed to change this street name to avoid confusion; and
- **WHEREAS**, Yechiel Way on Tax Map Sheet 124.02 is currently under development and the property owners on this street have agreed to this name change; and
- **WHEREAS**, the residents have requested that the street name of Yechiel Way on Tax Map Sheet 124.02 be changed to Hunter Drive, and Francine Segal, the acting Zoning Officer, has approved the availability of this name; and
- **WHEREAS**, it appears that all property owners on Yechiel Way on Tax Map Sheet 124.02 have agreed to change the street name change to Hunter Drive; and
- **WHEREAS**, the Township Committee of the Township of Lakewood deems it fitting and appropriate to change the name of Yechiel Way on Tax Map Sheet 124.02 to Hunter Drive
- **NOW, THEREFORE, BE IT ORDAINED**, by the Township Committee of the Township of Lakewood, County of Ocean, State of New Jersey, as follows:
- SECTION 1. The name of Yechiel Way, located as aforementioned and depicted on Tax Map Sheet 124.02 be and hereby is changed to Hunter Drive for the reasons set forth above.
- SECTION 2. That all ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

SECTION 3. This Ordinance shall take effect immediately upon final passage and publication as required by law.
