Committeeman D'Elia advised the town could either go to the Water Company and ask them to replace what they have removed, or possibly, ask if the Shade Tree Commission could help them out by planting some trees.

Committeeman Coles responded that they might not be able to plant trees over the water pipes. And if there are improvements, it is no longer a paper street.

Committeeman D'Elia advised that he has been back there, and agreed it is a problem.
