Project Goal:

Brick, Lakewood and Toms River Townships are the county's largest municipalities, "these three contiguous communities represent the population center of Ocean County." While each community is unique in character, all are plagued by the common elements of gang, drug and other criminal activity. The three largest communities also are host to several sites that have been identified as "critical infrastructure/key resource" by the United States Department of Homeland Security and the New Jersey Department of Homeland Security and Preparedness.

The primary goal of this initiative is to promote public safety, enhance intelligence based policing efforts and improving cooperation between these communities in Ocean County.

Project Identifiers:

This project will allow each department to apply individual solutions to many common problems. Brick Township Police Department will use its funding to enhance their *community based programs* to better combat the growing threat posed by criminal street *gangs*. The Toms River Police Department plans to fund both *law enforcement leadership* and *law related education* programs by establishing a computer-based training program for its officers. The Lakewood Police Department will enhance its joint capabilities to further develop its *terrorism preparedness* and *counter-terrorism* response.

Review Narrative:

Each department submitted their individual application to their respective governing bodies for review prior to submission of the grant application. The completed application remains on file with the Township of Lakewood.




