With regard to the residents present from Horizons at Woodlake Greens, Mayor Akerman announced that the Committee has discussed the matter, and they are willing to go to mediation and to work with them.

PUBLIC COMMENTS

Comments from the public will be heard for a limit of one (1) hour. Each speaker will have four (4) minutes and shall be limited to one time at the podium.

Mayor Akerman opened the meeting to the public.

Robert Rothstein, 78C Dorchester Drive – Commented with regard to the turn-around problem that they have in Leisure Village. Now that the Parkway construction appears to be almost completed, there was a proposal by the State to make a turn-around which would seriously impact the exiting of the residents from Leisure Village. He would like to know if any other plans have been made, as they have not heard anything about this for quite some time. They took the traffic light out, and you have to go way down near Costco to make the turn-around. They have asked for better signage at the Towbin Avenue jughandle so that you can go to Airport Road by going down Towbin Avenue and then take Oak Street to Airport Road. He would like to know if the town has any contact with the State to find out what is going to happen. The residents of Leisure Village are very concerned as it is a safety problem.

Committeeman Lichtenstein responded that the Committee members have been working with the residents with regard to this turn-around issue, and the Police have gone out there to help out. The concerns of the residents have been passed on to the State representatives, but they have not heard anything back. He asked the Manager to request that the Engineer reach out to the State to find out the plans for the turn-around, and to advise Mr. Rothstein of the results. He can be reached through the Homeowners Association office at Leisure Village.

Bill Hobday, 30 Schoolhouse Lane – Thanked the Committee for being responsive to the needs of the residents.

Noreen Gill, 192 Coventry Drive – Commented on the recent Planning Board Meeting concerning the Franklin Street Development Area and the Post Office building.

Alice Kelsey – Commented on the issue of clear cutting of trees; wants the Township Committee to take a stand in opposition to the clear cutting of trees. Commented on Resolutions on the Agenda concerning Safety Bussing of School Aged Children, why is it coming out of the Township Budget, and not the Board of Education Budget.

Committeeman Lichtenstein responded that the State Monitors said if the Township does not do it, they will kill the bussing. The Township made the money contingent upon a six-year plan from the State Monitor and the Board of Education going forward, with projections, and by the end of October or end of November, the State Monitor and the Board of Education need to provide the town with their thought process for the next six years so that they do not end up in this "crisis mode" every year.

Mayor Akerman added that if the State says no to courtesy bussing, then it is the Township's obligation, and they would have to spend well over the half million dollars to ensure the safety of those children.

Mrs. Kelsey asked about Resolution No. 34, awarding the Bid for the design of a parking facility; she wants to know the location.

Mr. Henshaw responded that the parking facility will be located at Ninth Street, and is being paid for under a grant from New Jersey Transit, at no cost to the taxpayers.

Gerry Ballwanz, Governors Road – Commented on issues at a recent Planning Board Meeting. Also commented on the sale of land by Cedarbridge Development.

Seeing no one else wishing to be heard, Mayor Akerman closed the meeting to the public.
