Green Acres Park Application(s) – Public Hearing – Ervin Oross, CDBG Director

Mr. Oross advised that they are making application to the State Green Acres Program for various improvements at seven (7) parks throughout the town, for a million dollar grant/loan. This is the public hearing portion of the advertisement that was made a couple of weeks ago. He asked if there was anyone from the public present who would like to comment on this Green Acres application for various park sites, and the source of funding.

Seeing no one wishing to be heard, Mayor Miller closed the meeting to the public.

Jersey Central Power & Light – Pete Johner

Mayor Miller commented that they are truly lucky that they live in Lakewood, where they live in a town with a lot of building and growth going on. People want to live here. At the same time, along with growth always comes growing pains. One of the issues they had a few years back was rolling black outs that took place all around Lakewood. At the time, it was very aggravating, and they were being told that it was due to the fact that there was a lot of growing going on, and they could not hold up to the power that was being provided. That was one issue. Another issue that came up was that they felt that the street lights were not being repaired in the proper time. At that time, he called for Mr. Johner to come to the meeting, and they lashed out at JCP&L and were furious and commenced a lawsuit. He is now pleased to turn the microphone over to Committeeman Lichtenstein to talk about everything that the same Pete Johner has done. Mayor Miller stated he was the first to chastise JCP&L. He is a man of his words, and now he is the first one to give JCP&L his appreciation.

Committeeman Lichtenstein agreed with Mayor Miller's comments. Their working relationship with JCP&L has grown. Just today he was in a meeting with Gregg Stafford-Smith and Pete Johner, and the heads of the Engineering and Line Departments, discussing the growth of Lakewood and how to prepare and make sure they have enough power going forward. They have worked very closely with JCP&L on the street lights. Recently, during Superstorm Sandy, JCP&L was constantly in contact with the Township, and it was due to a lot of hard work on Mr. Johner's part. Committeeman Lichtenstein further stated it is, and has been, a pleasure working with Mr. Johner, and will continue to be a pleasure to work with JCP&L.

Mayor Miller presented a plaque to Mr. Johner in appreciation of his dedication and commitment to the residents of Lakewood.

Mr. Johner thanked Mayor Miller and the Township Committee for this award. He appreciates it and is honored to receive it. They know that the town is growing, and they want to be there to fit the needs of that growth. They have the resources to do what needs to be done. He also announced that he is retiring from JCP&L on November 1, 2014. He said if anyone has any problems, to call him, and he will call the company to try to resolve it.

The reason for that is with government, things take time, and it takes weeks to process the purchase orders, so they want to make sure that the Township's utilities do not get shut off. With regard to Cable and e-mail, he does not believe that the Purchasing Department has been treating those as utilities. He would like to request to the Committee that they be treated as utilities, as recently e-mails have gone down because of a lapse in payment.
