PUBLIC COMMENT

Mayor Akerman opened the meeting to the public.

Walter Lucas, Newport Avenue – Commented on a traffic situation on Newport Avenue. Advised that the street is fifteen hundred feet long. With all the schools in the area, there are children walking up and down the street, as well as adults, which has created a lot of pedestrian traffic. All the residents on the street have either one or two acres, and the street is twenty feet wide, which is sufficient. What is needed is something to safeguard the pedestrians walking up and down the street. He is suggesting that the street be designated for No Parking. All the residents have ample room to park their vehicles on their properties. He also suggested that a speed bump be installed on the street.

Mayor Akerman responded that Public Works is against speed bumps because the snow plows can not maneuver over them, and the plows get ruined.

Committeeman Coles added that the Fire Department does not like the concept of speed bumps either.

Committeeman D'Elia asked Mr. Lucas if he has spoken with the other residents on the street to see if they are in agreement with the No Parking designation.

Mr. Lucas responded that they are all his relatives, and they are all in agreement.

Mayor Akerman asked the Municipal Manager to forward this request to the Traffic & Safety Division of the Police Department for their review and recommendation.

Joyce Blay, NJ News and Views, 311 Floral Way, Toms River – Asked if there are any of the appointed commissions or boards that include non-residents as their members.

Committeeman Coles responded, yes.

Ms. Blay also asked about the Ordinance on this evening's Agenda with regard to a legal matter. She asked if the Township has reached an agreement with Mr. Garzo to purchase his Corporate Park parcels, or whether they failed to do so, or is that the reason there is an action to condemn them.
