## **EXECUTIVE DIRECTOR'S REPORT:**

Mr. Corby: In correspondence, you may have seen All Chemical Transport's letter regarding my conduct, never mentioning the fact JCP&L didn't appreciate the uses of their Right of Way as storage of tanks after chemical transportation. We would normally approve anything JCP&L approves, but in this particular case, they didn't not approve the use. On another matter, the Lakewood Township Airport Authority has asked for a grant of \$15,000.00 for the design of electrified signage and this has been before the Commission previously. Mr. Mitchel Dolobowsky is here on behalf of the Airport Authority.

(At this time Mr. Albert removed himself from his seat as Commissioner and sat as a member of the public)

Mr. Corby: He is here to speak on the issue presented above. This was before us two months ago, the grant request figure has changed and I think this is a design matter being asked for consideration.

Mr. Dolobowsky: If I may, good afternoon, and thank you for allowing me to come on so late on the agenda. I am the vice-chair of the Lakewood Township Airport Authority and our job/charter is to develop the airport into a first class general aviation/hobbyist airport. We have a good number of acres out there (63 or 64). We are going to be developing it [the ancillary acreage], as non-airport use. It would likely be developed as a small office park. We wish you to consider us for award of a grant, as you have recently done with Cedar Bridge Corporate Campus, because they were considered a 'gateway to Lakewood' coming up from Cedar Bridge Avenue. When you're going to be working with them on their signage. Well, we are the first gateway. When you come off the Garden State Parkway (southbound), you are going to be facing our new entrance. And we would respectfully ask that you consider our application for similar design work so that we can present the proper face to the public, representing both Lakewood Township and the Airport Authority.

Mr. Corby: If I may, I believe some sketches were included in everybody's package. Was that for the Parkway entrance or the Cedar Bridge Avenue (entrance) location?

Mr. Dolobowsky: I think, temporarily, they would probably be where they are now because we have no choice, but our Master Plan is now complete. In doing the final response to the FAA as part of our Master Plan, which we foresee within the next two months, our Master Plan will be completed and we can begin to move forward. Then we can start planning where the new roads will be. My guess will be that the sign would be moved at the appropriate time.

Mr. Silberberg: What are we being asked to vote on here? About \$15,000.00? Is there a request here for the LIC to subsidize the Airport Authority? I'm reading this right?

Mr. Dolobowsky: ...to subsidize the design work on the signage. So, basically, the industrial park and that whole gateway area will have a uniform look to it as we welcome people into Lakewood.

Mr. Silberberg: Why would this be any different from any other business requesting a subsidy for a sign?

Mr. Dolobowsky: Well, we are an independent body right now, but we are an independent body fortunately and unfortunately. When we took over, a Master Plan had never been done by previous Township Committees. After these unexpected expenses, we are not able to proceed with business at hand, so to be very honest, we are between a rock and a hard place right now. And we are looking for a little support.

Dr. Eisenberg: There has been a lot of rumblings, positive and negative, about the Airport, which is of concern.

Mr. Dolobowsky: I don't think there have been 'rumblings', positive or negative. There is a group in town that would like to see it go away because they feel there are better uses for it (the property). However, an earlier township committee purchased the Airport with Federal money from the FAA. And in the contract, it says that airport will be kept a airport in perpetuity. I have a letter here from the FAA in New York that says that same thing. And therefore, it must be kept that way. There is some confusion over other language in the agreement. It also says that if there are some lands on the 'airport property' that are not needed for airport purposes, the FAA will grant a release, which is a release to use the land for other purposes. So, if your business wanted to put a building on our airport, we have to go to the FAA and get their approval. We are a separate entity in business but are restricted by the FAA. Everything we do has to be approved by them.

Dr. Eisenberg: What is the piece of property we are talking about?

Mr. Dolobowsky: It is the 60 acre tract right along Airport Road.

Dr. Eisenberg: That I know, what is it zoned right now?

Mr. Dolobowsky: It is zoned Professional Service / Light Office / Industrial

Dr. Eisenberg: It doesn't include the park or anything like that?

Mr. Dolobowsky: No there is no residential entity or heavy industry intended. And I think, out of respect to Bathgate, Gaming Labs International and the other corporations that have put up really nice buildings there. We're not looking to put up an industrial park. We are looking to match what is there and really make it a nice corridor.

Mr. Golub: I have a question/statement. I had been talking to Mr. Albert about coming to the meeting today, and also, earlier today, we had a brief conversation about signage throughout the entire industrial park. Now, I know we've spoken about that here but the theoretical proposal, with possibilities of Public Works, with John Franklin's expertise in the sign department, that saves the township money on signage, I have viewed a lot of those signs and I'm sure Mr. Corby has as well. Everyone has passed by them and looks at the disgraceful condition of the signage remaining even today. If you build one you have a fixed cost to build the second one. The fixed cost gets billed over. To build three. it dilutes your initial expenditures too. To build 12-15 signs, it is more cost-effective than to build just one. This would be the first sign going up of the new sign series, as I call it, throughout the Industrial Park and I am enthusiastic about that, because I think the airport needs it, but for design only, I have concerns. If it was incorporated and said something like 'design and construction', I would have no problem whatsoever, and the reason why I say that is because I know. I dealt with sign companies and am dealing with a sign company now with the building I am building on County Line Road. I ask for a proposal to show me and they ask what I want to put up there and they give me the cost of material, and the cost of labor. The cost of design is included in it, you know, like if I was giving you an estimate and am doing this building, I have to come up with some kind of scheme. If it said 'design and construction', I would have less of a problem with it. Now, I know the sign is needed because what is currently there is horrible. You mention a possible relocation of the sign. Why would that have to happen?

Mr. Dolobowsky: At present, we have a driveway on Cedar Bridge Avenue, east of the new traffic light by Swarthmore Avenue. It is a horrible and dangerous location, to be very blunt about it. Right now it leads to the trailer which serves as our terminal. The new Master Plan will show a new terminal more centrally-located along the runway with an entry road of Airport Road, which is a slower moving, safer, road. We are hoping to work with the Parkway to put it directly across the Parkway exit ramp (89) and then perhaps a traffic light at that location to control the whole thing in the future.

Mr. Corby: The original proposal that was sent before included construction and construction management costs. I think it was pretty much rejected for reasons of substantial consulting fees. What I think has been done here is "let's get the design; let's figure out the cost afterwards". Your point is well- taken.

Mr. Silberberg: It sounds to me that the Airport Authority will have the availability of funds down the road and were looking to the LIC, having funds now but may be running out down the road, so would it be prudent for us and acceptable for the Airport Authority to re-classify this request as a loan? That would be paid back in the future?

Mr. Dolobowsky: I can't say no to you, certainly we would take it. However, this body is willing to do it. But you laid some history down too. You recently provided a similar grant to another organization right in the industrial park, right up the road. Why should ours be treated differently from theirs?

Mr. Silberberg: I was unaware, what is he referring to?

Mr. Dolobowsky: Didn't you just do the Cedar Bridge Development grant?

Mrs. Doyle: The (Hillier) contract for design and construction of entranceway signage. That was for the baseball stadium entranceway.

Mr. Corby: When we built the stadium it was an entranceway designed to accommodate both the corporate park and the baseball stadium but that was in the midst of considerably different circumstances.

Mr. Dolobowsky: Ok

Mr. Silberberg: Is this signage in keeping with the theme?

Mr. Dolobowsky: I don't know that our design would be the same, but if you instructed us to make it of similar look am sure we can talk to our designers and say yes, make it similar to that. I will tell you now, we don't have a pre-determined vision. We are looking for something that looks good and when you come off the Parkway.

Discussion followed. In the end, the Commissioners all agreed to be billed directly (by the selected vendor) as progress of the signage continued and pay the vendors directly up to\$15,000.00.

Dr. Eisenberg/Mr. Golub- Motion to award the Airport Authority up to \$15,000.00 for signage design.
