Mr. Secare advised that the first sale is for the following properties:

Mr. Secare asked if anyone was interested in bidding on these properties, and requested they please come forward to the microphone.

Rabbi Stein, Yeshiva \_\_\_\_\_\_, 915 New Hampshire Avenue, and his home address is 960 West Kennedy Boulevard, Lakewood,

Rabbi Stein offered a bid in the amount of \$198,000.00 for Block 1130, Lot 1; and also offered a bid in the amount of \$148,000.00 for Block 1131, Lot 1.

Mr. Secare advised that Rabbi Stein was the successful bidder on both properties, and requested he leave the required ten percent with the Township Clerk, and follow up with his office.

Mr. Secare advised that the next sale would be for the following properties:

Mr. Secare advised that the minimum is \$890,000.00 and asked if anyone was interested in bidding on these properties.

Mr. Aithal, Esq., representing JSM of Brick, LLC, on behalf of JSM offered a bid in the amount of \$890,000.00.

Mr. Secare advised that they are the successful bidder and requested he leave the required ten percent with the Township Clerk and follow up with his office.

#### **PRESENTATIONS**

Mayor's Scholarship Award will be presented to Shea O'Neill, a Lakewood High School Senior who won the Ocean County Mayor's Scholarship this year.

#### **ORDINANCES FOR DISCUSSION: None**

Mayor Coles reviewed quality of life items from the May 17th meeting.

As to the issues in the Hearthstone development, Chief Lawson advised they have done a lot of enforcement in the area, including bike patrols, and made quite a few arrests. The residents have been very happy with the enforcement action being taken by the Police Department.

Mr. Mack added they also sent out a number of notices, and have cleaned up properties in the area.

As to the problems at 119 Shady Lane, Mr. Mignella advised that the adjacent property owner developed a drainage plan which will be implemented in two phases. Phase 1 was approved, it is staked out, but has not been constructed. If that fails to perform to the satisfaction of the property owner they have another system that they will have the owner install. As to 119 Shady Lane, they are continuing to monitor the property, and they do not see any evidence of water that is inundating his property.

Mayor Coles asked about the issue of late night working and lighting shining into his home.

Mr. Mignella advised he visited the property at night, as well as with one of the inspectors, and there was no evidence of lights shining into his home. The home construction is completed, so there should be no further construction noise.

As to issues brought up by Mrs. Jume, Mr. Mack advised he received a letter from the homeowner and they have agreed that now that the home is occupied, they will no longer leave the lights on at night.

Mayor Coles added he received a letter this week from Mrs. Jume stating that the problem is still there.

Mr. Mack stated that it seems to be occasionally when they forget to turn it out, but it is not on the electric eye anymore, so it is not on automatically every night.

As to the issue on Coral Avenue, and the request from Mrs. Abrams for a Stop Sign and radar, Chief Lawson advised that the Stop Sign was installed and was knocked down, and installed again. The radar board was installed within a week of the initial complaint.

As to the fence on John Street, Mr. Franklin advised that the fence has been installed.

# **Comments from Committee Members:**

Mr. Miller advised he received a letter from a resident on Park Avenue, and forwarded the letters to the Police Department, and Ed Mack, to follow up.

Deputy Mayor Lichtenstein advised that Senator Singer set up a meeting for him with representatives from JCPL to discuss the continuous issue of them not switching the street lights. He asked Chief Lawson to have the night duty officers provide him with pole numbers with regard to street light outages.

**COMMENTS FROM THE PUBLIC** will be heard for a limit of one (1) hour. Each speaker will have four (4) minutes and shall be limited to one time at the podium.

Mayor Coles opened the meeting to the public.

Milton Itell, Wisteria Court, speaking for members of A Country Place – Advised of a non-conforming use of property in A Country Place, regarding an illegal synagogue in violation of the ACP bylaws.

Mr. Secare advised he will research the matter.

Mr. Trumper, 119 Shady Lane – Asked when the next public forum will be held.

Mayor Coles advised he sent out letters and so far the only response he has received is from Harrogate, which he will set up for November.

Mr. Trumper further commented regarding the water problems on adjoining properties.

Mr. Mignella advised that they have recommended a C.O.; there is nothing to stop the applicant from moving in. There are no safety hazards, so he has to recommend a C.O. If they are doing some work, they are entitled to do so; they own the house. He sees no evidence of water on his property. As for the property behind the home, they will remedy that situation. He asked for Mr. Trumper to call when he has water, because he sees no evidence of water on this property.

Mr. Trumper commented on quality of life issues in his neighborhood. Many cars are parked along the street; you would not be able to get an emergency vehicle down the street. The curb has not been constructed properly where you can not get a school bus through safely due to the amount of cars parked.

Mayor Coles asked Mr. Mignella to look into the curb issue.

Mr. Mignella advised he has already done that. He checked with the surveyor who staked out the curb to verify the location, and as far as he knows, it was staked out correctly and is in the proper location,

Mayor Coles asked Chief Lawson to have Traffic & Safety look at the site, and maybe offer a recommendation to permit parking on one side only.

Mr. Trumper also complained about the large flood lights.

Mayor Coles also requested Mr. Mignella to look into the light issue to see if they are appropriately sized.

Felicia Torrelli, 208A Huntingdon Drive – Complained about handicapped parking at Charlie Brown's Restaurant.

Mr. Mack explained the plans to remedy the situation.

Gene Moyer, 8 Poppy Court, A Country Place – Complained about the residence in A Country Place that he feels is being illegally utilized as a place of worship. People are trespassing on his property, and through the development. He requested Police Department assistance to stop the trespassing.

Deputy Mayor Lichtenstein offered his help in trying to resolve the situation.

Alice Kelsey, 295B Malvern Court East – Asked about the status of the Robinson/Zimmerman bias/assault case.

Mr. Secare advised she can obtain that information from the Municipal Court Administrator.

Mrs. Kelsey further asked about future public forum meetings.

Chris Abrams, Coral Avenue – Thanked the Committee for the Stop Sign and radar board in her neighborhood. Also provided the address where a pool was constructed without a fence, located at 756 Coral Avenue. Also, asked for an update with regard to the Plan Endorsement process. Also asked how primary residences is a Lakewood resident permitted to declare.

Deputy Mayor Lichtenstein advised that he took a bus tour with the representatives from the Office of Smart Growth through Lakewood. They are making progress in declaring certain sites as environmentally sensitive. They are looking at many different options, and they will have another public meeting. Over the next few weeks, he will have more of an idea of when the next public meeting will be held.

As to the question regarding primary residences, Mr. Secare advised that you can have as many residences as you want, but you can only have only one domicile.

Charles Ferraro, Wisteria Court, A Country Place – Complained about the residence being used as a synagogue.

Bert Albert, Lions Head Woods – Commented on the construction of a new restaurant on Route 70. Also asked about the renewal of liquor licenses.

Mr. Secare commented on the liquor license renewals.

Frances Moyer, 8 Poppy Court, A Country Place – Complained about the synagogue in her development.

Sam Christopher, Central Avenue – Commented on the history of a primary residence.

Senator Singer commented with regard to A Country Place. If someone walks down the street to someone's home, it is not trespassing. If someone walks through someone's back yard, or comes from behind A Country Place, to enter A Country Place, it is trespassing. That is an issue they can deal with. It has nothing to do with religion; it has

to do with privacy and your own quality of life. The second issue is whether or not the house is not being used as a house, but being used as a house of worship. You can have a house of worship in any zone, but you have to come before the proper boards to get the proper parking, etc., for a house of worship. Part of the problem is, and Mr. Secare will research it, is if that particular property is off the tax rolls. If it is, it would have been declared as one of two things: either a parsonage, (where a rabbi, a priest, or someone lives), which is legal; or a house a worship. This is where he believes the Township has to work with A Country Place. This is against the bylaws of A Country Place, to operate your home as anything but a home. But you have to understand that action needs to be taken by the Board of Directors and Attorney for a Country Place. The Township should assist in that, only to the fact that this is infringing on the quality of life of residents of the community. Meetings to negotiate and talk about it are fine, but the end result has to be same end result.

Senator Singer continued that the trespassing matter can be handled by the Police Department. Secondly, a joint meeting between the Deputy Mayor and the community representatives, may help to resolve the matter. If not, he thinks it would be appropriate for the Township Attorney to meet with the Board Director to discuss a viable way to deal with this issue, and come back with an action plan.

Senator Singer requested that the Township Attorney be permitted to speak with the Board Directors, and that the Deputy Mayor contact the congregation to meet with them, and also that the trespassing must stop immediately. He also asked that the Chief of Police provide enforcement, and stop the trespassing from happening.

Deputy Mayor Lichtenstein advised he will reach out to the people from the congregation. He will wait for someone from A Country Place to contact him so he knows who to talk to, and have a contact person to set up a meeting.

Seeing no one else wishing to be heard, Mayor Coles closed the meeting to the public.

At this time, the professionals left the meeting.
