

ORDINANCE NO. 2012-40

SUMMARY

The following Ordinance of the Township of Lakewood authorizes the Township to vacate all of the right, title and interest of and to the public in a paper street known as Sophia Street measuring approximately fifty (50) feet in length, as further outlined by description contained in the Ordinance, which paper street remains unimproved, and is not needed for public road purposes. The vacation of the subject paper street has been requested by adjoining property owners. The vacation of Sophia Street lends itself to higher and better use than for public road purposes, and that it is in the best interest of the general public and the Township of Lakewood that any public easements, right and interest in and to same shall be vacated, released and extinguished.

SUMMARY

The following Ordinance amends Chapter 11 of the Code of the Township of Lakewood, entitled "Traffic", Section 11-18, entitled "One Way Streets", to provide for a one way street designation on Goldcrest Drive to Washington Street, westbound, from Alley 1, permitting parking on both sides of the roadway facing westbound from Alley 1 to Washington Street; and also on Hawk Way to Washington Street, westbound, from Alley 1, permitting parking on both sides of the roadway facing westbound from Alley 1 to Washington Street.
