NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners of Fire District No. 1, Township of Lakewood, County of Ocean, State of New Jersey, that the compensation for each commissioner for fiscal year 2025 shall be set in the amount of fifteen thousand dollars (\$15,000.00) per year under the terms and conditions set forth above; and

BE IT FURTHER RESOLVED, a copy of this Resolution shall be forwarded to the Township of Lakewood governing body with accompanying correspondence from the Fire District Administrator for their review and approval
